We are conducting detailed surveys of users of information, in developing countries and countries, to find out what exactly they need to help them to make aid more effective. We have found that the main needs for more information are:

- more detail about how aid is being spent
- more up-to-date information (ideally, information in real-time);
- more timely and detailed information about anticipated future aid flows;
- a way to trace aid as it moves from one organisation to another, from funder to recipient;
- broader coverage including bilateral donors, multilateral organisations, foundations and NGOs;
- sufficient detail so that information can be organised according to local definitions;
- easier access to the information in formats which can be integrated into local systems.

We are also working with donors to find out what information they already have and what is available. We have found that a surprising amount of information is already published, either in documents or collected through multiple, parallel reporting systems. Unfortunately, because of the way it is

published, much of this information is out of date by the time it is available, and it is difficult to access, compare and aggregate. Other information that is needed to make aid more effective is already collected by donors for their internal purposes, but is not currently published in the detail required
