In 2010 and 2011, Oxfam supported local partner organizations to conduct community-based HRIAs with tobacco farmworkers in North Carolina and with mining-affected communities in Bolivia. In our experience, community-based HRIAs have: (1) built human rights awareness among community members, (2) helped initiate constructive engagement when companies have previously ignored community concerns, and (3) led to concrete actions by companies to address concerns.
